Release, Waiver, Identification, Hold Harmless and Assumption of Risk Agreement

WHEREAS, in consideration of receiving instruction in firearms which include: attending a course for instruction in firearms, instruction in firearms, use of the class room, use of the range facilities, range-site use and instruction, firearm loading and discharging, firearm maintenance, and similar activities related to the training in and use of firearms ("Services") provided at a classroom, shooting range or other facilities and travel to and from the classroom, shooting range or other facilities ("Premises"), and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Undersigned agrees to the following:

Undersigned agrees to indemnify, hold harmless and release Dry-Fire Training Pistol Company, Inc., its instructors, employees and agents (herein after referred to as "Instructors") from any and all fault, liability, cost, expenses, claims, demands or lawsuits arising out of, related to or connected with: Undersigned's receipt of and/or participation in the Services, presence on or use of the Premises and, any and all acts or omissions of Instructors or Undersigned.

Undersigned waives for himself/herself and for his/her executors, personal representatives, administrators, assignees, heirs and next of kin any and all rights and claims for damages, losses, demands, and any other actions or claims whatsoever, which he/she may have or which may arise against Instructors or Premises (including but not limited to the death of Undersigned and/or any and all injuries, damages or illnesses suffered by Undersigned or Undersigned's property), which may, in any way whatsoever, arise out of, be related to or be connected with: participation in or receipt of the Services and/or presence on or use of the Premises, including any latent defect in the Premises; Undersigned's property (whether or not entrusted to Instructors); and, the discharge of firearms. Instructors shall not be liable for, and Undersigned, on behalf of himself/herself and on behalf of his/her executors, personal representatives, administrators, assignees, heirs and next of kin, hereby expressly releases the Instructors from any and all such claims and liabilities.

Undersigned acknowledges, understands and expressly, knowingly and voluntarily assumes any and all risks and dangers, including the risks of property damage, serious bodily injury and death, of firearms, ammunition, the discharge of firearms and the receipt of or participation in the Services and the presence on or use of the Premises.

Undersigned agrees that Undersigned has read this instrument and understands its terms and is executing this instrument voluntarily. Undersigned furthermore hereby acknowledges and agrees that he/she has read, understands and will at all times abide by all range rules and procedures and any other rules and procedures stated by the Instructor. Failure to comply with these agreement may result in termination from participating in or receiving the Services, without refund. Undersigned understands that Undersigned has the sole responsibility to understand this agreement, all applicable laws and regulations and understands that the Instructors are not providing legal advice and that Undersigned has had the opportunity to consult a licensed attorney for any legal advice.

Undersigned expressly agrees that this agreement is intended to be as broad and inclusive as permitted by law, and that if any provision of this agreement is held invalid or otherwise unenforceable, the enforceability of the remaining provisions shall not be impaired thereby. No remedy conferred by any of the specific provisions of this agreement is intended to be exclusive of any other remedy, and each and every remedy shall be cumulative and shall be in addition to every other remedy now or hereafter existing at law or in equity or by statute or otherwise. The election of any one or more remedy hereunder by the Instructor shall not constitute any waiver of Instructor's right to pursue other available remedies. This agreement binds Undersigned and his/her executors, personal representatives, administrators, assignees, heirs and next of kin.

Undersigned agrees that the exclusive jurisdiction for any and all disputes arising out of or related to this agreement shall be in the federal, state or local courts of Greenville County, South Carolina and the laws of South Carolina shall apply.

Undersigned agrees to hold harmless and release and forever discharge Instructors from all claims, demands, and causes of action which I, my heirs, representatives, executors, administrators, or any other persons acting on my behalf or on behalf of my estate have or may have by reason of this authorization. I am 21 years of age and am competent to contract in my own name. I have read this release before signing below and I fully understand the contents, meaning, and impact of this release.
